Regulations

By signing this form, you agree to be entirely responsible for the boat and any of its contents loaned to you by RS Sailing or the Class Association. Your charter will end when the loaned boat and all accessories have been loaded onto the return convoy and the charter form has been signed by a member of RS Sailing of RS Association staff present. You are required to return the boat dressed in the manner agreed at the time of charter. Non compliance will result in a flat charge of £100 being deducted from your deposit.

Insurance

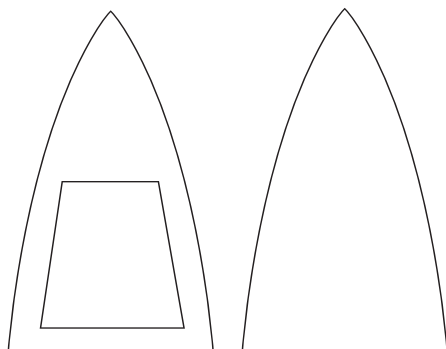
The Charter boat has a third party Liability Insurance of £5,000,000. The Deductible (Excess) is £500.

Damage

You are responsible for the first £500 (600 Euro) of any damage or loss of components. In the event of a collision between two charter boats both parties are liable for the first £500 regardless of fault. If your charter boat is damaged by a third party your deposit will be withheld and it is your responsibility to recover this value from the Third Party or their insurance.

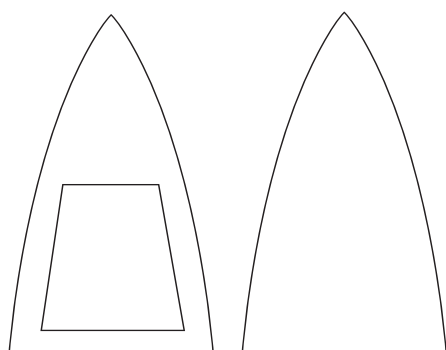
